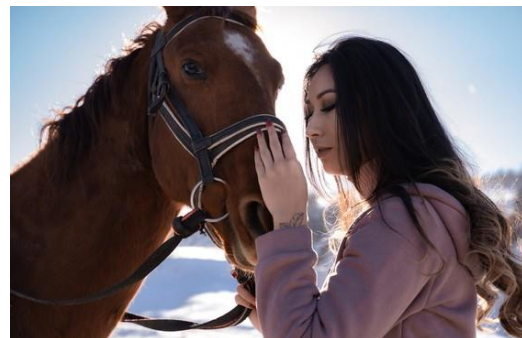

Rules of behaviour at the "At Mikhalych's" Fazenda

Country Complex "At Mikhalych's" Fazenda is a private complex, on the territory of which there are a number of Rules, which you should familiarise yourself with.

1. At the entrance to the territory, free parking is provided for the Guests of our complex. Please observe the rules of safe parking.
2. It is prohibited to travel by car on the territory of the Complex.
3. Check-in time for guests staying at the hotel is 14:00, check-out time is 12:00.
4. Check-in time for day-stay guests is 11:00, check-out time is 22:00.
5. Breakfast (Swedish board) takes place in the restaurant "Berloga)) from 09:30 - 10:30.
6. If you use a mini-bar in the room, do not forget to pay for these services.
7. It is necessary to observe silence, cleanliness, not to leave behind food waste, bottles and garbage.
8. Smoking on the territory of the Complex is allowed only in specially designated areas.
9. Do not use excessive efforts when using the equipment of the room - you bear the costs of compensation for possible damage.
10. Garbage is allowed to be thrown out only in garbage cans.
11. The complex administration is not responsible for the loss of valuables, money and documents left in the room.
12. The search for forgotten things is conducted independently and at your own expense.
13. Movement on the territory of the Complex is allowed only on paths and paths. We ask you to take care of the grass cover, as well as not to damage shrubs and trees.
14. Swimming is allowed only in the pool area. It is forbidden to enter the restaurant and move around the Complex in bathing clothes.
15. There is a playground next to the contact zoo. This playground is designed for preschool children (up to 7 years old). Parents are personally responsible for their children staying at the playground.
16. In order to avoid cases of poisoning by non-industrial (home-made) food products and beverages (alcoholic and non-alcoholic) carried by guests to the territory of the Complex, due to the possible non-compliance of such products with quality requirements and / or storage and transportation of products to the territory of the Complex, the management of the Complex, in accordance with the sanitary rules in force in the territory of the Republic of Kazakhstan and requirements, established the regulations for bringing non-industrial (home-made) food products and beverages by guests to the territory of the Complex, which are allowed to be brought into the territory of the Complex only if there are appropriate documents certifying the safety of food products brought into the territory of the Complex.
According to the current norms established in the Law of the Republic of Kazakhstan "On food Safety)), the document certifying the safety of food products is a certificate of state registration, veterinary and sanitary conclusion, veterinary certificate, veterinary certificate, certificate of conformity, declaration of conformity certifying the conformity of food products, the conformity of the processes (stages) of development (creation), production (manufacture), turnover, disposal and destruction of food products, compliance of machinery and equipment, materials and products used in the development (creation), production (manufacture), turnover, disposal and destruction of food products, the requirements established by the legislation of the Republic of Kazakhstan on food safety.
17. Guests of the complex are obliged to comply with the requirements of the current legislation of the Republic of Kazakhstan.
18. Guests are prohibited to violate the Rules of Behaviour established in the complex, otherwise the complex is not responsible to the Guest for the harm caused to the Guest's health due to violation of the established Rules of Behaviour at "At Mihalych's Fazenda".
